### RECOMMENDED ACTION BY CITY COUNCIL

Staff recommends the following action:

"I move to authorize the execution of the Assignment and Assumption of Beneficial Interest in Water Rights from Sione P. Otuafi and Finau Sepi Otuafi to Robert C. Herrera and Donnia Herrera in the amount of 4.78 acre feet."

## **SUPPORTING INFORMATION**

It is policy for the City of Fernley to have City Council approve all assignments of banked water from one party to another before it is considered final.

Fernley's records currently show the beneficial interest of 4.06 acre feet of water rights are banked in the name of Sione P. Otuafi and Finau Sepi Otuafi. The water was originally dedicated by Sione P. Otuafi and Finau Sepi Otuafi via Deed 239970 recorded on 10/08/1999. The Deed transferred a total of 5.18 acre feet of water rights to the City of Fernley. An amount of 1.12 acre feet of this water right was used for connection to water service at 1560 East Farm Lane. Sione P. Otuafi and Finau Sepi Otuafi would now like to assign the remaining 4.06 acre feet of that interest to Robert C. Herrera and Donnia Herrera.

Fernley's records also currently show the beneficial interest of 0.72 acre feet of water rights are banked in the name of Sione P. Otuafi and Finau Sepi Otuafi. The water was originally dedicated by Sione P. Otuafi and Finau Sepi Otuafi via Deed 239968 recorded on 10/08/1999. The Deed transferred a total of 0.72 acre feet of water rights to the City of Fernley. Sione P. Otuafi and Finau Sepi Otuafi would now like to assign 0.72 acre feet of that interest to Robert C. Herrera and Donnia Herrera.
