“I move to authorize the execution of the Assignment and Assumption of Beneficial Interest in Water Rights from D&S Limited to Trident Plus, LLC in the amount of 4.28 acre feet.”

2. D&S Limited has requested to assign all 4.28 acre feet of its beneficial interest to Trident Plus, LLC.

Fernley’s records currently show the beneficial interest of 4.28 acre feet of water rights are banked in the name of D&S Limited. The water was originally dedicated by D&S Limited via Deed 386578 recorded on 7/17/2006. The Deed transferred a total of 4.28 acre feet of water rights to the City of Fernley. Marc E. Simoncini, sole successor of D&S Limited, would like to assign the entire 4.28 acre feet of interest to Trident Plus, LLC.
