Public Comment for Business Impact Study Transient Lodging Tax 2018

City staff members are soliciting information from businesses regarding the proposed Transient Lodging Tax increase from 9% to 11%. We are soliciting the information to prepare a "Business Impact Statement" pursuant to NRS 237.090. The current Transient Lodging Tax is nine percent (9%) of the gross income received, excluding the lodging tax, by each licensed transient lodging rental business for transient lodging rentals. Currently each licensee is, and shall be, required to add the amount of the transient lodging tax onto the amount of the transient lodging rentals due from each lessee. The use and purposes of transient lodging tax proceeds is used to promote tourism to the City of Fernley and to operate, maintain, improve, extend, construct, purchase civic facilities that are under the jurisdiction of the City Council.

Interested parties are encouraged to provide written comments by completing and submitting the Public Comment Form. Any and all comments, data, or arguments must be received by Wednesday, November 7th, 2018 by 5:00 pm to be considered for the Business Impact Statement.
