Fernley Methodist Church addition is seeking a will-serve for .12 water ERC's and .35 sewer ERC's to be used to add an ADA restroom and a kitchen.
Pursuant to FMC 32.39.060(a), commercial properties where the calculated ERC is less than 0.5 may pay a fee in lieu of dedication of a water right. The in lieu of fee for the requested will-serve is \$619.80 for water and \$1215.90 for sewer which will be required to be paid before issuance of the will serve commitment.
