AGENDA ITEM: Staff Report (For Possible Action): Possible Approval to fund the Fernley Living Faith Food Pantry Tier 1 costs in the amount of \$33,094.99 and Tier 2 costs in the amount of \$39,000.00 using the CARES Act funding.

Agenda Item Brief: The Fernley Living Faith Food Pantry has increased their monthly clientele nearly 75% from March 2020 to March 2021 due to the pandemic. To keep up with demand the food pantry is requesting CARES Act funding to assist with operating costs, fund improvements, repairs, and staffing. The City has CARES Act funding available to fund the request.
