PROJECT SUMMARY:

The Meadows at Inglewood is seeking a will-serve for 0.56 water ERC’s and 2.97 sewer ERC’s to be applied towards the tenant improvements for a pizzeria in building I building shell on Lyon County Parcel 020-341-01 located at the at 1046 Inglewood Drive Unit #100, Fernley, NV 89408.

Water and sewer connection fees will be paid at the time of building permit issuance in the amount of \$12,272.20.

BACKGROUND:

The Meadows at Inglewood holds a beneficial interest in 15.01 acre-feet of water rights dedicated under a Groundwater Dedication Agreement in 2007.

In August of 2018, The Meadows at Inglewood used .98 ERC’s (1.1 AF) for Building – A located at 1030 Inglewood Drive, Fernley, NV 89408.

In August of 2020, The Meadows at Inglewood used .79 ERC’s (.88 AF) for Building – H Located at 1044 Inglewood Drive, Fernley, NV 89408.

In February 2021, The Meadows at Inglewood used 2.15 (2.4 AF) water ERC’s and 6.9 sewer ERC’s to be used to for the TMAI Events Center.

In March 2021, The Meadows at Inglewood used .53 (.59 AF) water ERC’s to be used for the TMAI Unit 100 – Yogurt Beach.

In December 2021, The Meadows at Inglewood used .93 (1.04 AF) water ERC’s to be used for the TMAI Unit 110 – Steak House.

Accordingly, prior to the issuance of this will-serve request, The Meadows at Inglewood has 9.0 acre-feet of uncommitted water remaining under the banking agreement prior to the issuance of this will serve.

The water needed for this project has been previously dedicated under a prior banking agreement. City staff has determined that the City has adequate water and sewer resources to support the requested will-serve commitment.
